General Conditions

- Midnight Heating Services, Inc. (Midnight Fuel) and the customer agree there are no promises, terms, conditions
 or obligations other than those which are included in the plan. This plan may not be modified orally and all
 modifications require the signature of an officer of Midnight Heating Services, Inc. (Midnight fuel).
- 2. This plan does not cover repairs or materials required because of damaged by fire, water, seepage and leaks for pipes, vents, force or other acts of God and in no event shall Midnight Heating Services, Inc. (Midnight Fuel) be liable for consequential of special damages or for the failure to delay to respond if such failure or delay is occasioned by riot, smoke, fire, flood, force or other acts of God.
- 3. Within 30 days after agreement, Midnight Heating Services, Inc. (Midnight Fuel) shall have the right to terminate this contract without penalty if upon inspection of equipment it ascertains it is not in proper working order or repair.
- 4. This plan does not cover parts required or service rendered as a result of Power Interruptions, insufficient water in the boiler, insufficient fuel when the customer is not on the automatic delivery system or when the customer's deliveries have been held due to an overdue balance. Services rendered under conditions outlined in this paragraph will invoiced at prevailing rates.
- 5. This plan does not cover service rendered as a result of customer's failure to replace fuse or reset circuit breaker, set thermostat properly turn on emergency switch, open valve, bleed air, drain expansion tank, clean air filters, baseboard, radiators and ducts. This plan also does not cover water leaks or any plumbing unless otherwise specified under this plan. Services renders under conditions outlined in this paragraph will be invoiced in accordance with the provisions.
- 6. During the evening hours and Saturday, Sunday and Holidays only EMERGENCY Service will be provided. Minor complains are will be scheduled and taken care of during the normal workday.
- 7. For any breach of this plan, negligence or other failure whatsoever on the part of Midnight Heating Services, Inc. (Midnight Fuel) then Midnight Heating Services, Inc. (Midnight Fuel) is hereby limited to performing the work only.
- 8. Midnight Heating Corp (Midnight Fuel) shall not be responsible for water freeze up or oil spills if caused by a change in the customer's pattern of fuel oil consumption or customer's use of alternate sources of fuel causing Midnight Heating Services, Inc. (Midnight Fuel) to be unable to determine the proper delivery schedule under automatic delivery system.
- 9. Midnight Heating Services, Inc. (Midnight Fuel) shall not be required to deliver oil on the "Will Call" system and shall determine whether a customer qualifies for the "Automatic Delivery" system.
- Midnight Heating Services, Inc. (Midnight Fuel) will not be responsible for damage resulting form clogged oil vent, fill pipe or water in oil tanks from any other damage cause beyond Midnight Heating Services, Inc. (Midnight Fuel) control.
- 11. If the customer's oil consumption fall below the minimum of 700 gallons per year, Midnight Heating Services, Inc. (Midnight Fuel) at its sole discretion shall have the right to cancel this plan and bill the customer the annual rate of service contract. If this occurs, then Midnight Heating Services, Inc. shall reserve the right to bill all oil burner service, including parts, performed during that period at the Company's prevailing rates for parts and labor.
- 12. If a customer cancels their contract prior to the end of this plan, Midnight Heating Services, Inc. (Midnight Fuel) shall reserve the right to bill all oil burned service, including parts, performed during that period at the Company's prevailing rates for parts and labor.
- 13. In compliance with regulation "Z" of the U.S. Federal Government our Finance Charge is 1-1/2% per month for all past due balances over 30 days which is a true annual percentage rate of 18%. In the event of the default by purchaser, purchaser further agrees to pay attorney's fees necessary for the collection of any sums due to Midnight Heating Services. Inc. (Midnight Fuel).
- 14. The Customer agrees to pay company standard service rates plus parts, when any portion of their heating system isn't covered by this contract.
- 15. Midnight Heating Services, Inc. (Midnight Fuel) also reserves the right to refuse all service without notice if the customer is in the arrears of fails to pay any bill within 30 days.
